- 1. The Government of Telangana has formed "SC SPECIAL DEVELOPMENT FUND (SCSDF)"& "ST SPECIAL DEVELOPMENT FUND (STSDF)"for the Financial Year 2017-18 duly earmarking the required funds for ongoing schemes covering SC/ST beneficiaries /works. Various innovative schemes are newly proposed besides the existing schemes in implementation under SCSDF & STSDF.
- 2. Government has proposed to develop a robust Fund Monitoring system to track expenditure on these two funds. Centre for Good Governance (CGG) has been entrusted with the development of a detailed SC/ST fund monitoring system encompassing all the Govt. Schemes which has a component of expenditure on SC/ST beneficiaries or works.
- 3. The first step is to categories /classify all schemes and subschemes under the department as Individual / family/habitation/works /other. It is also decided in the meeting held with CGG, Agriculture and Animal Husbandry department that details on IT system usage need to be captured from each department to decide the mode of data handling and integration to analyze and give desired reports. CGG has prepared an online format to capture these parameters for each scheme/subscheme.
- 4. The website can be accessed at <a href="http://scstfms.cgg.gov.in">http://scstfms.cgg.gov.in</a>. The details of the user credentials created for all the Head of Departments is enclosed and the default password is guest. Help manual is provided in the login.
- 5. All the Head of the departments are requested to complete the data entry of schemes/sub-schemes categorization details by 27.04.2017 and upload the same in CGG Portal and printout the same may be sent to SCSDF & STSDF in Finance Department and officials of Secretariat Departments shall closely monitor and ensure the completion of the data entry of Schemes/ Sub-schemes details.
