ORDER:

In an effort to establish state-of-the art IT applications for effective Public Finance Management, the Government has decided to establish a Comprehensive Financial Management System (CFMS), which would provide seamless and dynamic interface with all stakeholders and facilitate effective financial management and real time information sharing with stakeholders, especially in budgeting and accounting processes. This system will increase the efficiency in financial transactions, transparency in operations and facilitate effective control and accountability of the financial management system at all levels.

2. In this context, the Government has requested for Proposals from leading national and international IT firms to establish and maintain CFMS for the Government of Andhra Pradesh. The deadline for receipt of Proposals is 21 September 2012. As stipulated in the Request for Proposal (RFP), the evaluation will include a two-stage process, i.e., technical evaluation followed by opening of financial bids of those qualified in the first round.

3. The Government, after careful examination of the issue, hereby constitute a Technical Evaluation Committee (TEC) for conducting technical evaluation of the Proposals with the following members.

4. The Terms of Reference of the Committee shall include:
- (i) Pre-qualification of bidders as per the criteria specified in the RFP;
 - (ii) Technical Evaluation of the pre-qualified bidders and shortlisting the responsive bidders;
 - (iii) Opening the financial bids of the responsive bidders and ranking them for consideration of the High Powered Committee.
5. The Government orders that the recommendations of the above Technical Evaluation Committee shall be placed before the High Power Committee (HPC) constituted vide G.O.Ms.No.121, I&CAD (PW-COD) Department, dated.15-10-2004 for review and approval of the recommendations of the Technical Evaluation Committee. The Principal Finance Secretary shall be the convener of the High Power Committee for the tender review and confirmation.
6. The Government, duly following the standard procedures, will review and approve the recommendations of the High Power Committee.
